ABUNDANT LIFE ACADEMY PARENTAL COVENANT AGREEMENT

(PLEASE READ CAREFULLY, SIGN AND RETURN TO SCHOOL, REGISTRATION IS NOT COMPLETE WITHOUT SIGNED CONTRACT)

To this agreement between ABUNDANT LIFE ACADEMY SCHOOL and _____,
we agree to the following: (Parent/Guardian's Name)

1. We understand the general philosophy of Christian education, and are in agreement with the purpose and intent of Abundant Life Academy.
2. We agree to uphold and support the high academic standards of the school by providing a place at home for our child(ren) to study and to give our child(ren) encouragement in the completion of homework and assignments.
3. We understand and agree to the following financial policy:
 - A. Tuition is charged by the year. In order to accommodate the student who enrolls after the beginning of the year, tuition will be prorated. In the event that a student withdraws during the school year, the parent/guardian is responsible for the academic year's tuition and fees to be paid in full. We agree that should we fail to pay tuition and fees and the Abundant Life Academy institute collection efforts, that in addition to any other legal or equitable remedies, that Abundant Life Academy is entitled to all fees and costs incurred, including attorney's fees and costs, in the collection of any amounts due and owing to the Abundant Life Academy.
 - B. Tuition is an annual fee. For your convenience we offer 3 options to pay tuition:
 1. Payment in full, due by the first day of school (4% discount).
 2. Two half payments due in September and January.
 3. Ten payments through enrollment in tuition acquisition company.

The first tuition payment is due in August. There are ten (10) payments due each month from August through May. Students whose accounts remain delinquent will not be able to attend classes unless arrangements are made through the business office. A late fee is added on delinquent accounts. All bank fees for check returns and/or miscellaneous fees are to be paid in full by parent/guardian.
 - C. All tuition and fees for the entire school year, regardless of whether paid up front, or under the monthly payment plan are due and owing and are non-refundable.
4. We will support the school by: involvement in school-sponsored meetings and activities, volunteerism when necessary with lunch programs, fundraisers, etc. and participation in fundraising. Therefore, we will support a required fundraising commitment of \$400.00 per family or opt for the \$200.00 buyout program.
5. We give permission for our child to take part in all school activities, including bus trips, sports activities and school sponsored trips away from the school premises. All school rules apply on all field trips.
6. We understand that the standards of Abundant Life Academy do not tolerate disrespect to the personnel of the school or continued disobedience to the established policies of the school.
7. We acknowledge that there may be times when we must partner with the school in disciplining our children and agree to work with teachers and staff to honor all school policies, specifically including, but not limited to the Parent Cooperation Policy. We understand that Abundant Life Academy will NOT administer physical discipline.
8. We give consent for photographs, audio, video, electronic or digital images or likenesses of our child(ren)/student(s), to be used by ALA for exhibition, public display, publication, publicity materials, advertising, a news media story, video, audio, or other electronic media, including but not limited to, yearbooks, newspapers, promotional brochures or literature, the Internet, a school website, television, CD-ROM or DVD.
9. We understand that assessments will be made to cover damages to the school, including breakage of windows and abuse of other personal property whether intentional or accidental. Abundant Life Academy is not responsible for lost, stolen or damaged property.
10. We will faithfully support the school through our prayers and positive attitude and will not share any complaints, questionable or negative comments (regarding administration or faculty) around our child(ren) or other parents.
11. We understand that failure of parents and students to comply with the Handbook requirements, school policies, established regulations and discipline, Parental Covenant Agreement and financial obligations, can jeopardize the student's enrollment status and result in a forfeiture of the student's privilege of attending Abundant Life Academy.
12. We understand that programs are offered for care outside of school hours and do agree to abide by the policies and procedures as set forth in our Handbook.
13. Abundant Life Academy admits students of any race, color, national and ethnic origin.
